## **Relevant extracts from the Articles of Association and Bye-laws of the Association**

### ***Eligibility of membership***

Any proprietor/ partnership firm ,company, Joint Hindu family or other body incorporated or unincorporated connected with Import of Jute Goods in India may be eligible to be a member on his/their agreeing in writing to the secretary to be bound by the Articles, Bye-laws and other Rules and Regulations of the Association which are now or hereafter in force and are applicable provided he/she is not debarred from membership under any provision of these Articles or of the Bye-laws or of the Association, for the time being in force.

### ***Committee or sub-committee decision regarding acceptance of member is final***

The Committee or the sub-committee who shall be competent to accept or reject an application of membership shall decide as to the admission of a new member or the eligibility or otherwise of a candidate for admission and their decision shall be final & they shall not be bound to give any reason for such decision.

### ***: Admission & Subscription Fee***

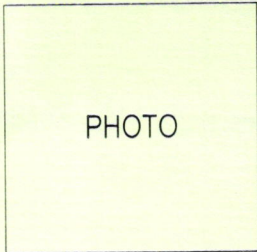
- The admission fee payable on election and subscription to the Association payable annually by members shall be as may be fixed by the Committee from time to time.
- All applications for membership shall be made together with the admission fee and subscription for one year. The subscription shall be payable by a member for the official year of the Association, irrespective of the date of his election to membership.
- The admission fee and annual subscription are, in no case, refundable except when the application for membership is not entertained by the Association.

### ***Candidate for membership shall be proposed and seconded***

Every Candidate for membership of the Association shall sign, and submit the application in the prescribed form for the purpose and shall be proposed by one and seconded by another member of the Association

### ***Right to apply for membership after rejection***

If any candidate's application for membership be rejected he will be competent to apply again on expiry of 6 (six) months from the date of rejection of his application.
